Rules and Regulations Revisions

After listening to homeowner comments, the Board is currently conducting a thorough review of the Lake Crest Homeowner Rules and Regulations. To date, we have voted to amend the rules listed below. We are also working to review and potentially modify others. Until rules have been officially reviewed, modified, and voted on by the board, they will be enforced as they currently read. They will be posted on the website when we have completed review, as each time something is changed on the website, our webmaster charges a \$25 fee. Please note changes below:

Rule #6 Mulch - The board voted unanimously to change the language to read "All ground cover must be natural color on all landscaped areas and surfaces. Examples include pine straw, pine bark, pine mulch or lava rock. Lawns and beds shall be maintained on a seasonal basis and kept free from weeds." Voted on and approved by the LCHOA Board on 04/22/14

Rule #7 Entry Accessories - The board voted unanimously to change the rule to read "Décor on front door shall be well-maintained, inoffensive, appropriate and in keeping with neighborhood aesthetics." Voted on and approved by the LCHOA Board on 04/22/14

Rule #14 Front porches, part B, planters-The board voted unanimously to change the rule to read "Planters may not contain dead plants, weeds, or artificial plants/flowers." Voted on and approved by the LCHOA Board on 04/22/14

The Lake Crest Homeowners' Association is now on Facebook! We have set up a closed Facebook group for Lake Crest residents to share information of interest to other neighbors. Since so many people use Facebook regularly, this provides a way to communicate information more quickly than our bi-monthly newsletter allows.

To join the group, type Lake Crest Homeowners' Association into your Facebook search box. When you reach the page, you will see a prompt that enables you to ask to join. We have three page administrators—Janie Bryant, Tricia Farris and Amy McCarthy—so your request should be approved quickly. By making this a group that requires authorization to join, we hope to protect the privacy of residents and minimize the amount of outside spam.

We hope that you will find this a convenient way to receive HOA news and to communicate information of interest to your neighbors. We ask that you keep all posts and responses pleasant and constructive.

We will continue to send out the Lake Crest News six times per year and will also post information on the Lake Crest website, www.lakecresthoa.com.

Pool Update

This summer the HOA has received a number of complaints about non-residents using the pool. Please remember that the Lake Crest Pool is for the use of residents and their guests only and the access code should never be given out to non-residents. Residents may bring up to four guests; however, the HOA reserves the right to limit use of the pool to residents only during weekends and holidays if the pool is extremely crowded.

All residents should sign in immediately upon arriving at the pool.

Our pool rules are designed to make the pool a safe and enjoyable place for all. Traffic Concerns Continue

Speeding on the streets in Lake Crest continues to be a topic of concern for many residents. The subject is raised at every HOA meeting and a number of residents have also expressed their concerns on our neighborhood Facebook page. **Please obey the posted speed limit when driving on our streets.**

Now that school is out for the summer, our children are playing in their yards, riding bikes or walking to the pool. We also have many walkers and joggers who exercise on our sidewalks in the evenings. With so many people out and about, it is especially important that drivers be extra cautious and recognize the consequences that excessive speed could have. Several residents have commented that traffic speeding down the hill from the stop sign at Flag/Trumpet Circle is a real danger. In addition to obeying the posted speed limits, please be sure to come to a complete stop at all stop signs. If you have a teen driver in your family, please discuss this with them and be sure to set a good example!
