## From the President

WOW! What a summer Lake Crest has had: tons of rain, flash floods, roof and side walk replacements, and last but not least, several new stop signs on Lake Crest Drive. Fortunately most of the roofs are covered by insurance, Hoover has repaired the damaged sidewalks and cleared some storm drains. Your water and sewer bills should not have been quite as high and hopefully we have slowed down the habitual speeders. I hope everyone has enjoyed the pool and Food Truck Thursdays. Our health rating has been 100 during every pool inspection this year and the food from the food truck vendors has been very good.

After the first flash flood Jody and I met with Hoover's Engineering Department and they cleared some drains—unfortunately, not all of them in time. Later after the second episode of flooding we met with Alabama Power representatives and walked some areas of the power line easements where tremendous amounts of water have been running onto Lake Crest homeowners' yards. What we found was surprising: it seems that a lot of homeowners from Lake Crest and adjoining neighborhoods along the Alabama Power easement have been using these areas to dump shrubbery, grass clippings, limbs and even several trees. The properties around these easements are yours and the adjacent property owners and they should be kept up on a regular basis and never be used as a vegetation dump. The worst case of flooding was created by recently cut shrubbery restricting water flow thru the drain opening just behind a homeowners' fence. We have asked Hoover Engineering to provide us a map of where all storm drains inlets and outlets are in Lake Crest so we can have them inspected on an annual basis. Recently Hoover has made some additional repairs to the storm drains. Sometime in mid-October Alabama Power crews will removing some trees that are approaching a dangerous height to the power lines and maybe they will have to remove some of existing debris and overgrowth so they can get to the tree removal sites. I hope everyone enjoyed their summer vacations and are ready for school and looking forward to fall events.

## 2017 Annual HOA Meeting

The Annual Lake Crest Homeowners' Meeting will be held on Monday, November 13, 2017 at 7 p.m. at Lake Crest Presbyterian Church. Last year the board voted to make a change in the date of the annual meeting from January to November to allow the HOA budget to be adopted on a calendar year basis. Among the items of business will be the election of three HOA board members. Board members serve a three-year term and attend every-other-month homeowners' meetings, as well as called board meetings. Candidates are asked to fill out a short information form indicating interest in serving on the board. The form will be available on the Lake Crest website, [www.lakecresthoa.com](http://www.lakecresthoa.com), in early October. We will also send out an email blast reminder with a link to the form. All applications must be received by Friday, Oct. 27. Prior to the annual meeting, homeowners will be mailed a voting proxy form with information about the candidates. If you have questions about serving on the board, please contact Lake Crest business manager Jody Northcutt. As in previous years, homeowners' dues notices for 2018 will be mailed in January.

## Leaf Collection Schedule

It won't be long before autumn leaves begin to fall. The City of Hoover and Santek Waste Removal have announced changes to the leaf collection schedule for 2017-18. Instead of six zones, the city will now be divided into three zones. Each zone will have four pickup periods and trucks will run for two weeks in the zone during that period. Lake Crest is located in Zone Two. Collection dates are: First Collection - Nov. 20 to Dec. 1; Second Collection - Jan. 2 to Jan. 12; Third Collection - Feb. 12 to Feb. 23; Fourth Collection - March 19 - March 23. The scheduled collection dates could be delayed due to rain or snow. Please rake leaves to the curb the day before the first scheduled day for the zone.

- Make sure there are no twigs, branches, rocks, bricks, bags or other items in your leaves that could create an obstruction in the vacuum hose of the leaf collection trucks. Place large trash items at curb for the knuckle-boom truck to collect.
- Do not use your recycle bin for yard debris.
- All loose leaves should be stored in containers or bags until your pickup time. Please do not leave loose leaves at curb to blow into storm drains or neighbors' yards.
- Pile leaves away from storm drain openings and storm drain lids, fire hydrants, mailboxes, utility wire and other equipment.
- Make sure vehicles are not parked near your leaf piles.
- Leaf pile should not extend further than four feet from the curb or asphalt. The leaf collection truck's vacuum hose cannot reach leaves that are further away.
- Bagged leaves will be collected at the curb with your regular garbage collection. If you have more than 10 bags of leaves, please call or submit request through RequestTracker to arrange for pickup or call 205-444-7543.

## From the Architectural Review Committee (ARC)

Please be aware that per the Lake Crest Covenants homeowners must request approval from the ARC before making any changes to exterior or landscaping of their home. This includes, but is not limited to, improvements such as re-roofing, window or door replacement, painting, fencing, deck replacement or additions, and landscaping, including removal of any trees. Forms to request ARC approval are available on the Lake Crest HOA website, [www.lakecresthoa.com](http://www.lakecresthoa.com), and should be submitted to Property Manager Jody Northcutt prior to beginning any work on the home. Please be sure to fill out the forms completely and provide all the requested materials so that requests can be handled as quickly as possible. Please submit your requests well in advance of the proposed start date for your project. The ARC does its best to handle all requests promptly, but must consider requests in the order they are submitted, allowing sufficient time for review by all committee members.
