Guard Against Auto Break-ins

Over the summer, there have been several reports of car break-ins in the neighborhood. Please remember to:

- Lock your vehicle and make sure the sunroof and all windows are closed. Twenty-five percent of vehicle thefts are from unlocked cars.
- Make sure your car's alarm system is activated.
- NEVER leave valuables in plain sight. Bring all valuables into the house or place them in a locked trunk. If you have an SUV or vehicle that leaves your cargo area open, get a retractable fitted cover to keep shopping bags and other belongings hidden. After you've put your belongings in the trunk, don't forget such telltale evidence as power plugs, MP3 adapters, and navigation system windshield suction-cup mounts. Thieves know what they're looking for, so hide the electronic accessories, too.
- Don't leave spare keys in your car.
- Etch your driver's license number on valuable items and/or record the serial numbers to aid police in recovering your items if a thief attempts to pawn them.
- Watch for suspicious activity and report it promptly to the Hoover police.

Mailbox Maintenance

It has been over two years since the HOA asked homeowners to make sure their mailboxes were in compliance with the Lake Crest Rules and Regulations and many mailboxes and posts are showing need of maintenance. If your mailbox is in need of a touch up, please refer to Rule 4 of the Lake Crest Rules and Regulations for the proper paint colors according to your section of Lake Crest. Rules and Regulations Revisions

The Board has revised Rule 15 of the Lake Crest Rules and Regulations. The Rules and Regulations and Covenants governing all homes in Lake Crest can be found on the Lake Crest HOA website:

<u>www.lakecresthoa.com</u>. The revised rule reads as follows: Only one sixteen square (4'x4') foot or smaller American flag may be displayed at the front or side of the house. Flagpoles attached to the ground are strictly prohibited..

One sixteen square foot or smaller university/sports team flag or U.S. military service flag may be displayed on the front or side of the house. Only one university, sports team or U.S. military service flag may be displayed at any time.

Small garden flags, pennants or banners must adhere to the same guidelines as the security signs.

All flags shall be maintained in good repair and flown observing proper flag etiquette.

School Rezoning Information By Janie Bryant

As most of you are already aware, Lake Crest is at the forefront of the Hoover Board of Education rezoning discussions, along with Bluff Park and Deer Valley Elementary schools. During the next phase of this implementation, middle schools, Simmons and Bumpus, and high schools Hoover High and Spain Park, will be reevaluated.

How does this affect you and your family?

As Lake Crest homeowners, this "realignment" could impact us in the following ways:

1)Potential Property Value Reduction

2)Quality of Education for our elementary children?

3)Transportation safety and driving times for teens if they are rezoned for Spain Park.

4)Family division: Siblings going to different schools. (i.e.- older sibling is grandfathered into current school and younger sibling would be zoned for new school. Impractical driving scenarios for families who have children who are zoned for two different schools.

What are we going to do/ What can you do?

On August 4, there was a Hoover School Board meeting. There were 10-15 residents who attended and several who spoke on behalf of our neighborhood, including myself. Prior to this meeting I wrote a letter stating opposition to the proposal of rezoning from Gwin to Trace Crossings, from Simmons to Bumpus, and from Hoover High to Spain Park High. There was an attached petition available for homeowners to sign at the pool; however we had only a total of 55-60 signatures.

Personally, I am scheduling a meeting with Trace Crossings principal to discuss the school, test scores, behavior issues, etc., as I previously taught in a low-income school that had low test scores and understand some of the challenges; I would like to hear how she is addressing these issues in her school.

I have been emailing Mr. Craig's secretary trying to set up a meeting with a time and location that is conducive for all to meet. Initially, Mr. Craig wanted to meet during the school day at 2:00p.m.; however, I suggested another date, as most parents are at work during this time or picking up their children from school at this time. After several days, they gave us the date of **August 26th at 5:00p.m. at the Lake Crest Clubhouse**. Unfortunately, this is the same date as "Back to School" night for some children at Gwin Elementary and for all of Simmons. I am asking for at least one parent in the household to represent your family at the clubhouse. If our neighborhood is not interested in this "cause", I will stop pressing to have our voice heard. Please support the children in our neighborhood and attend this meeting. I look forward to seeing you there.
