## **Traffic Complaints Continue**

Speeding and on-street parking continue to be issues of concern to many Lake Crest residents. At the annual Homeowners' Meeting held earlier this month, several residents spoke out about the problems created when cars are parked on the street and the dangers that speeding cars pose to both people and property and they asked that the Homeowners' Association act on these problems.

On-street parking: According to Section 9-104. of the Hoover City Municipal Code, "It shall be unlawful for any person to park any vehicle: (1) Upon any portion of any paved roadway in the city having a width of twenty-four (24 feet) or less."The majority of streets in our neighborhood are less than 24 feet wide; therefore, any on-street parking is a violation of city ordinances and police can and will ticket offenders when notified.

Parking on the street reduces the road from two lanes to one. Several of our streets have areas where visibility is limited and moving to the middle of the road to avoid parked cars creates the potential for a collision with oncoming traffic—especially if those cars are exceeding the speed limit. In some cases, on-street parking causes a situation that would make it difficult for emergency vehicles to respond to a call. Several residents have commented that cars parked on the street either block their driveways or make it difficult for them to get out of their driveways.

Speeding/Stop Signs: Please obey the posted speed limit on all streets in Lake Crest and come to a complete stop at all stop signs. Remember that we have children who often play in their yards and may dart into the street to retrieve a toy. We also have many walkers and joggers who cross the street at intersections. Of particular concern are cars speeding down the hill on Lake Crest Drive toward the Clubhouse and cars coming down the hill toward Preserve Parkway from the intersection of Flag Circle and Lake Crest Drive.

Despite frequent homeowner requests, the HOA has no authority to enforce Hoover traffic ordinances within our neighborhood. It is up to each of us to be considerate of our neighbors and their safety and to obey these ordinances. Please ask visitors and tradespeople to park in your driveway. If you see a situation that you think poses a danger, please contact your neighbors directly or call the Hoover police who have assured us that they will issue tickets.

## **ARC Update**

As you begin planning repairs, replacements and improvements to the exterior of your home or landscape this Spring, please be sure to secure the necessary approvals from the Lake Crest Architectural Review Committee before beginning any work. ## **Limbs and Landscape Debris**

As the weather begins to warm, many residents will begin trimming crape myrtles and other shrubs and trees. If you hire a landscape contractor, please ask that they haul away any limbs. Trimmings that are placed curbside for pickup should not block the sidewalk or street.



Please note the following information from the City of Hoover's website, www.hooveral.org, regarding pick up of limbs and landscape debris:

To be added to the list for a special collection, contact Allied Waste at 205-923-1650, City of Hoover Public Works Department at 205-444-7543 or submit online. Crews on the garbage trucks can sometimes gather small piles of limbs but in most cases it is best to inform us. Only debris generated by the homeowner will be collected. It is the responsibility of hired landscapers, tree services, roofers, remodeling companies, etc. to remove any materials/debris generated by their crews.
